For NEW ordinances established after the approval of this Bond Schedule, pending the recreation of the Bond Schedule, the base bond for the violation of the new Ordinance shall be the minimum forfeiture or one-half (1/2) of the maximum forfeiture, whichever is greater.

Throughout this Bond book the Bonds include the base forfeiture, to which is included a penalty surcharge mandated by the State (Currently set at 26% of the forfeiture), crime lab fee mandated by the State (currently \$13.00), a jail surcharge mandated by the State (currently \$10.00), and court costs, which are set by Ordinance (currently at \$38.00.)

In any event that any said costs, fees or surcharges increase, or if new costs, fees or surcharges are added, pending recreation of this Bond Book, all such revised or created costs, fees or surcharges shall be added to the amounts in this Bond Book.
