

**NOTICE OF JOINT PUBLIC HEARING REGARDING REVENUE SHARING

PLEASE TAKE NOTICE that a joint public hearing shall be held on August 23, 2017, at 6:30 o'clock p.m., at Mary D. Bradford High School Auditorium, located at 3700 Washington Road, Kenosha, Wisconsin, regarding a proposed Revenue Sharing Agreement and Cooperative Plan between the Village of Somers, Town of Paris and City of Kenosha under the provision of §§ 66.0305 and 66.0307, Wisconsin Statutes. A person may comment on the Revenue Sharing Agreement and Cooperative Plan during the hearing and may submit written comments on the Cooperative Plan before, at, and within 20 days following the hearing. Comments shall be considered by the Village, Town and City before finalization of the Revenue Sharing Agreement and Cooperative Plan.

The Cooperative Plan includes provisions affecting the common boundary lines between the Village, Town, and City and also includes provisions concerning the timing of said boundary changes and the circumstances that must exist before certain boundary changes may occur. The Cooperative Plan also includes provisions regarding the provision of municipal services within the territory specified therein. The Revenue Sharing Agreement contains provisions concerning the sharing of certain specified revenues by and with the Village and Town. The Revenue Sharing Agreement and the Cooperative Plan both contain many additional provisions.
