## RECONSTRUCTION OF COUNTY KR (COUNTY H TO OLD GREEN BAY ROAD)

The Wisconsin Department of Transportation (WisDOT) is currently reconstructing 16.5 miles of multi-lane roadways in and around the Wisconsin Valley Development. As part of this construction, County KR, between County H and Old Green Bay Road, is being reconstructed. Highlights of the construction schedule are provided below.

### COUNTY KR

- **The following work is scheduled to take place in 2020:**
  - > Begin reconstruction of County KR, between County H and WIS 31, to a 4-lane concrete roadway.
  - > Begin reconstruction of County KR at the CPRR and UPRR crossings and Pike River.
  - > County KR, between County H and WIS 31, is scheduled to close to traffic through 2022.
- **The following work is scheduled to take place in 2021:**
  - > Continue reconstruction of County KR, between County H and Old Green Bay Road, to a 4-lane concrete roadway.
  - > County KR, between County H and WIS 31, remains closed to traffic through project completion.
  - > County KR, between WIS 31 and Old Green Bay Road, is scheduled to close to traffic.
  - > WIS 31, at County KR, will be reduced to one lane in each direction while the intersection is reconstructed.
- **The following work is scheduled to take place in 2022:**
  - > Continue reconstruction of County KR, between County H and WIS 31, to a 4-lane concrete roadway.
  - > County KR, between County H and WIS 31, remains closed to traffic through project completion.
  - > Reconstruct/realign the 90th Street and 72nd Avenue (County EA) intersection.
  - > Project restoration.
